4. EXHIBITOR:

For any company participating in TEMTECH-2018, the organiser reserves the right of participation.

5. ELIGIBILITY OF EXHIBITS:

- 5.1 An Exhibitor who is either associated with the agent for another firm and who wishes to exhibit the product of another firm or firm must state at the time of making application for space the name of the firm(s) to be represented at the Exhibition and undertake to confine the exhibits to the goods of such firm(s). The name of such firm(s) must display on the stand throughout the Exhibition period.
- 5.2 Allotment of space by the organisers shall not imply that they accept the proposed exhibits, and the Exhibitor must satisfy himself that his exhibits comply with the Regulations. The Organisers reserve the right to exclude and / or require to be removed any exhibit which in their reasonable opinion is not within the scope of the Exhibition or is not suitable for the site allocated to the Exhibitor. The decision of the Organisers as to the eligibility of exhibits will be absolutely final and binding.

6. SPACE ALLOCATION / PAYMENT CONDITION:

Space Requests should be

25% advance payment With Booking Confirmation, 25% before 20th May, 2018 and balance 50% payment by 10th August, 2018.

The prospective Exhibitors should apply on Application for Participation Contract Form together with payment. Allotment will be on "first-come-first served" basis subject to receipt of all payments. All payment should be made by Demand Draft / Cheque in Favour of 'MIRROR EVENTS MANAGEMENT'.

Application for space, both indoor and outdoor, may be made in combinations/ multiples of continuous plots/booths. For a combination of continuous, furnished indoor standard booth allotted, provision of partitions within the area would be optional Rental includes passes for Exhibitor Staff manning stands during the Fair, One Free Entry in the Fair Catalogue

Acceptance of Application for Participation Contract Form must be submitted as per clause no. 6.

The Organiser reserves the right to reallocate space, change the layout, add or delete corridors in space plans-which may affect the orientation of some EXHIBITIORS. 8. APPROVAL FOR DESIGN OF STAND

Every exhibitor availing Raw Space only will have to submit their drawing and to scale mock-up, complete with details of Exhibit, Electricity and other installation and elevation in four copies for approval of the Organiser before 15th July,2018

SALE OF EXHIBITS

Sales are not allowed during the Fair. However negotiations for sale may be

10. HANDLING OF EXHIBITS, CUSTOMS AND IMPORT:
Services for handling, clearing and forwarding would be available at the Grounds at extra cost. The Organiser will appoint Clearing and Forwarding Agents for TEMTECH, who will assist in handling and completing Customs formalities if required. Exhibitor would be required to contact them directly for such assistance. Movement of exhibits in the Fair Ground by agencies other than the official Clearing and Forwarding Agents is prohibited.

11. EXHIBITS FOR DISPLAY:

Exhibits for display during the **TEMTECH**, can be brought into the Fair Ground from Thursday 20th, September, 2018.

12. STAND COMPLETION:

Exhibitors must ensure that their stands are ready by 24.00hrs on Friday, 21th, September, 2018. with all Exhibits in position. (Late connection will attract penalty @ Rs.1000/hrs of delay)

13. REMOVAL OF EXHIBITS:

The Organisers tenancy of the Exhibition Venue terminates at 23.5 Hrs. Tuesday Sep. 25th, 2018. All non portable exhibits and other property of the Exhibitor, hiscontractors and agents, must be removed from the Exhibition venue by the exhibitors or an amount on per hour basis would be changed from the exhibitor.

14. DAMAGES TO THE FAIR GROUND:

Exhibitors will be required to make good all damages or make payment adjustable against caution money in lieu there of the Fair Ground Facilities/buildings etc. incurred during setting up and/or Fair Period and/or dismantling period.

15. CANCELLATION:

If company withdraws from this contract after having concluded the said contract, the company hereby agrees to indemnify the exhibition management/ organiser for the losses at the following rates

17. PHOTOGRAPHY:

18. SETTLEMENT OF DUES:

Any and all expenses chargeable to exhibitors must be settled before the closure of the Fair to ensure smooth removal of goods from the Fair Site.

19. DISPUTE RESOLUTION AND GOVERNING LAW:

All unresolved matters, questions, dispute or differences whatsoever arising between the exhibitor and organisers shall be settled by arbitration in accordance with the rules of the arbitration and conciliation Act 1996. The arbitration proceedings shall be conducted in the bhilwara, India. The Arbitration agreement contained in this paragraph shall be solely and exclusively governed by the laws of India.

20. FORCE MAJEURE:

If the exhibition is abandoned, cancelled or suspended in whole or in part by reason of war, fire, national emergency, labour dispute, the non-availability of exhibition premises or any other cause not within the control of the organisers, the organiser may, at their entire discretion, repay the rental paid by the Exhibitor, or part there of, but shall be under no obligation to repay any of such rental and shall be under no liability in respect of any action, claims or losses.
